Please note that our fixed fees do not include disbursements. Disbursements are costs related to your matter that are payable to third parties, such as Home Office fees, Court/Tribunal fees and visa application fees. If any disbursements are applicable to your case, they will be outlined at the earliest possible opportunity.
